Jane D. Wolverton was featured in Vol. 3 #3 (May/June 1995), p. 113 of the newsletter. At that time her husband's ancestry was not proven. Since then, through using some IGI files which were sent to me by Kilburn Stoner, I have been able to track down the rest of her husband's lineage. David Macdonald has also compiled records on the early generations of this line. In addition, there is some information on Garrett Hopkins Wolverton and related information found in Royal Wolverton's <u>Cousins Unlimited</u>, Dec. 1981, pp. 3-5.

<u>Margaret Josephine "Peg" (Woolverton) Wright</u> was born June 24, 1928 in Grand Junction, Mesa County, Colorado. She is the only child of Monta Harold Woolverton and Elizabeth Jesse (Dodson) Woolverton. She attended public schools in Grand Junction. Graduating from high school in 1946 she then attended and graduated from Mesa Junior College in Grand Junction in 1948 with an A.A. degree. That year she entered Hastings College, Hastings, Nebraska, and in 1950 graduated with a B.S. degree in Education.

While at Hastings College she met Jim Wright. Later they were married at Grand Junction, Colorado, on 17 June 1951. She taught school in Grand Junction one year. Then after they were married, and relocated to Aurora, Colorado, she taught in Aurora for 11 years. She and Jim moved to San Jose, California in 1966, where Jim was employed by Lockheed and Peg enjoys keeping busy with church activities, clubs, and painting lessons. Jim retired in 1990, and now they enjoy getting out in their motor home and seeing some of the country once in awhile in addition to the above activities. Her husband, Jim, is the family genealogist.

Van Wolverton is somewhat new to genealogy and has been taking the newsletter for 3 years now. However, he is quite familiar with computers and has been building a database of as many Wolvertons as he can find. He has a degree in . English from Colorado State University, and he has written a number of books about computers, mostly about DOS, the operating system for IBM PC-compatible computers. He also worked for IBM for 10 years. With IBM he was sent to Europe a few times, and he was able to visit some of the Wolverton places there. He says, "I had a couple of weekends to wander around the countryside and discovered that there are four towns named Wolverton--well, three villages that are little more than crossroads with a few houses and a pub, and one town of about 12,000 on the main rail line from London to Northhampton." He hopes to go back and find out more about these towns in England to see if there is any connection to

## our family.

Van was born October 16, 1939 at Billings, Montana. He was named after his paternal grandmother, Valeria <u>Van</u> Osdol, and took his father and grandfather's middle name of William. Van was raised in Montana, but his family left about the time he started high school. After his books began selling pretty well, he convinced his wife, Jeanne, that they should move to Montana. With FAX machines and modems and very occasional travel, they can keep up just fine without having to live in the city.

Last April 12th, Van and others in his small community weathered a disastrous chlorine spill when 18 cars of a Burlington Northern Santa Fe Corp. train derailed. It released a cloud of toxic gas and more than 100 people were treated for medical problems due to the accident. One person, a hobo on the train, was killed in the spill. The townspeople of Alberton had to stay out of town for about 3 weeks. The damaged chlorine cars were kept in Missoula, 40 miles away, awaiting orders to ship them out. In light of national news this year, no doubt, Van and his wife are saying we don't need any more chlorine, Unibombers, or Freemen.

Van and Jeanne Wolverton have three grown children, and three grandchildren. Edward William "Bill" Wolverton III (b. 10 April 1962 at New Iberia, LA) was named for his paternal grandfather and great-grandfather. He married on January 2, 1988 to Lisa Annette Hanson at Holy Cross Catholic Church in Santa Cruz, CA. They have two sons: Christopher Michael, b. 12 Dec. 1990 Santa Cruz, CA; and Andrew Addison, b. 10 Aug. 1994 at Santa Cruz, CA. Bill is a senior engineer for Borland International, a software company in Scotts Valley, CA. Lisa has worked as a model and as a bilingual medical receptionist, but currently is a stay-at-home mom.

Katherine Theresa "Kay" Wolverton (b. 16 Jan. 1965 at Fort Collins, CO) was named for her maternal great-aunt and greatgreat-aunt. She married on June 21, 1994 to Henry Yutaka Ito at Pismo Beach, California. Kay is a development officer (fund-raiser) for the Denver Children's Museum; Henry is a buyer for Intelligent Electronics. They have a brand new baby boy, Jack Michael Junichi Ito, b. Wednesday, June 19 at Denver Colorado.

Andrew Wolf "Andy" Wolverton (b. 16 January 1966 at Pocatello, ID) has his maternal grandmother's maiden name for his middle name. He married on 16 July 1994 to Kelley Marie Welykholowa. Andy is sports editor of the Gardnerville, Nevada <u>Record-Journal</u>. Kelley is a kindergarten teacher. They have no children.

In the back of some of Van's recent books is this sketch:

"A professional writer since 1963, Van Wolverton has had bylines as a newspaper reporter, editorial writer, political columnist, and technical writer. He wrote his first computer program--one that tabulated political polls--for the <u>Idaho</u> <u>State Journal</u> in Pocatello, Idaho, in 1965. His interests in computers and writing have been intertwined ever since. As a computer professional, Wolverton has worked at IBM and Intel and has written software documentation for national software companies, including Microsoft Corporation. He is the author of <u>Hard Disk Management</u> and <u>MS-DOS Commands</u>, both Microsoft Press Quick Reference Guides, and <u>Supercharging MS-DOS</u>. He was also a contributor to <u>The MS-DOS Encyclopedia</u>. Wolverton and his wife, Jeanne, live in a twenty-first-century log cabin near Alberton, Montana."

Three other books he has written include <u>Running MS-DOS</u>, 5th ed. (1991); <u>Running MS-DOS</u> (1993), and <u>Van Wolverton's</u> <u>Guide to OS/2</u> (1993).

<u>Gretchen Wolverton</u> (no middle name), was born February 23, 1944 at Worland, Wyoming, and now lives at Denver, Colorado. She is a sister of Van Wolverton above and also is a subscriber to the newsletter. She has 3 children: 1) Christopher James Hardy (b. 22 Nov. 1963, age 33) is married to Patricia Hall. # WARNING TO SUBSCRIBERS!!!!!!!!!

On March 23, 1995 the National Genealogy Society requested an investigation of Halbert's Inc. Brochures and flyers have been mailed to genealogical libraries and societies to alert people on what to do when they see advertisements which may be misleading.

Consumers are warned that several companies sell coats of arms or "ancestral arms" for thousands of surnames which are most likely not related in any way to the purchaser's ancestry. Artists are employed who may adapt a coat of arms from one found in a book or they may even design or create a coat of arms for a surname for which none exists. This is false and misleading marketing.

Other misleading practices are the sale of books that supposedly give the history of your surname. Yet, when the purchaser receives the book, it is only a general study of history and how to begin tracing one's ancestry. Often only scant references are made to anyone of the surname requested, and sources are usually not given. Often the only thing of value is a listing of addresses of people with the same last name, but this would only be helpful if researching a rare surname. Address lists, if desired, can be obtained through local telephone books and mailing lists. A telephone listing for the entire United States is now available on CD-ROM and can be found in some libraries around the country. These can also be purchased for private use.

Certain companies mass produce their products, changing only a few details to make them appear different. A book of information about various individuals with the same last name is not a family history, nor is a list of names and addresses for individuals with the same surname any form of genealogy. Unless your surname is very rare, you should not assume that people with the same surname are related to you.

<u>UPDATE:</u> Charles L. Seaman just sent me a copy of Vol. 22, No. 2 (March/April 1996) of the <u>National Genealogical</u> <u>Society Newsletter</u>. It has a lengthy article called "Halbert's Under Cease and Desist Order." The cease and desist order was issued by the United States Postal Service in November 1995. One of the current provisions which Halbert's must follow is to include a disclaimer on their mailings: "No direct genealogical connection to your family or ancestry is implied or intended." Here is a listing of some of the companies which sell family books and/or coats of arms which include false and misleading information:

[Note: The above quarterly newsletter has almost no usable information whatsoever. No sources are given for information and each issue is full of advertising. Just to "check it out" I subscribed for one year. In one issue they advertised that the next issue would be about (my family name) in Canada. The next issue and succeeding issues made no mention of Canada. I wrote a letter of inquiry. The company sent a replacement copy, but still no mention of Canada! Really, the only "family" information within 4 issues was a listing of recent deaths as taken from Social Security records. Only the years and ages were given--not even the locality was given.

This company also offers a mass-produced book called <u>The</u> <u>History of the (Your surname) Family</u> which is called "a not so serious look at (Your surname) family roots" and is advertised as "the infamous 'tongue in cheek' story of our family." It is obvious that this book would be totally worthless. One advertisement says they, The Family News Network, research nearly 15,000 surnames and publish <u>Since</u> the Civil War books for each. Does that tell you anything?

The latest is that they have a book entitled <u>Three</u> <u>Centuries of ....</u>" (Fill in the blank with your surname). One recipient of this book (Suzanne Badenhop) received in it a soundex search of one census in 1870 or 1880 and didn't even get the Badenhops that she had found in the same census!

Currently one of our <u>Wolvertons Unlimited</u> subscribers is receiving the Family News Network's newsletter under the title, <u>The Wolverton Family News</u>. Please beware of this and all mass-produced "family history" products which include false and misleading information.--ed.]

It also includes a list of 141 Gohr "namesakes" who have died in the last century--this same information is available on the Social Security Death Index at the local library here--for free!!--ed.]

Know all men by these presents that that I Thomas hanks of the county of Anderson and State of Texas for and in consideration of the sum of one hundred and sixty dollars to me in hand paid by John Wolverton Sr. of the same county and state the receipt of which I hereby acknowledged have this day bargained sold transfered and conveyed and by these presents do bargain sell transfer and convey unto him the said John Wolverton Sr. his heirs administrators and assigns forever the one half (being one hundred and sixty acres of the head eight unconditional land certificate of James Reel for three hundred and twenty acres of land issued to him by the board of land commissioners of Cherokee County on the 15 day of February A.D. 1852 No. 55 class 3rd also one half of the conditional head eight of said class for three hundred and twenty acres of land class 3rd

assigns and I do by these present authorize and empower him the said John Wolverton Jr. his heirs or assigns to apply for demand and <u>require</u> from the commissioner of the general land office of the state of Texas a patent in his own name and for his own for said land and if necessary to appoint one or more attorneys under <u>hire</u> to obtain the same.

In Testimony whereof I do herunto inscribe my name and affix my hand for a seal this 10th day of July, A.D. 1854.
